If the number of voters exceeds the number of voting devices, pursuant to MGL 39 Section 10, the Moderator shall designate an overflow room for vote by show of hands and shall appoint an Assistant Moderator, pursuant to MGL 39 Section 14 to preside at and regulate proceedings in overflow room or take any other action there on. <i>*Majority vote Required to defeat Indefinite Postponement</i>	Indefinite Postponement passed by a Majority vote in favor declared by the Moderator.
