Shall the Town of Westwood approve the charter amendment proposed by the 2017 Annual Town Meeting Vote on Article 34 as summarized below?


**SUMMARY:**


The 2017 Annual Town Meeting voted to rescind the acceptance of three sections of the General Laws relating to the Fire Department which set forth the authority of the Fire Chief. The Fire Chief will now be under the oversight of the Board of Selectmen and Town Administrator as are all other department heads. The effect of a Yes vote will ratify the vote of the May 2017 Annual Town Meeting. A No vote will disapprove the vote of the May 2017 Annual Town Meeting.
