Dear Ms. Powers:

Article 14 - We approve Article 14 from the November 13, 2017 Westwood Fall Annual Town Meeting.

Articles 10, 11 and 12 – The Attorney General's decision on these Articles will be issued on or before our current deadline of May 24, 2018.

Note: Pursuant to G.L. c. 40, § 32, neither general nor zoning by-laws take effect unless the Town has first satisfied the posting/publishing requirements of that statute. Once this statutory duty is fulfilled, (1) general by-laws and amendments take effect on the date these posting and publishing requirements are satisfied unless a later effective date is prescribed in the by-law, and (2) zoning by-laws and amendments are deemed to have taken effect from the date they were approved by the Town Meeting, unless a later effective date is prescribed in the by-law.

To Whom It May Concern:

I hereby certify the following action taken under Article 14 of the Warrant for the Fall Town Meeting held on November 13, 2017

Annual Town Meeting, Article 14: The Finance and Warrant Commission recommended and the Town voted by a 2/3 voice vote in favor declared by the Moderator to amend § 184-10. Licensing; dogs worrying, maiming or killing livestock. C. (1) of the Town bylaws by adding §184-10. C. (2):

(2) Effective January 1, 2018 any person seventy (70) years of age or older, upon proof of age, shall be exempt from the annual fee for one dog, per household, per year. The owner of a kennel license, age seventy (70) years of age or older shall be excluded from this exemption. Dogs must still be licensed on or before March 31st of any given year per town bylaws § 184-10. C. (1)
