

#### PROCEDURE FOR OBTAINING A RAFFLE PERMIT

A Raffle Permit is valid for one year from the date of issue. In all cases(except for the first time) a financial report for the previous year must be submitted to the Town Clerk's office before any renewal can be issued.

Organizations applying for the first time must have been organized and actively functioning as a non-profit organization in the Commonwealth of Massachusetts for not less than two years prior to applying.

All funds derived form any raffle or bazaar must be used exclusively for the purpose stated on the application.

First: The applicant may obtain the following forms from the Town Clerk:

- 4 copies of Form 810 (Application for Permit)
- 2 copies of Form 812 (Financial Report)
- 1 copy of Form RBL-1 (green Notice of Issuance)
- 1 raffle & bazaar questionnaire

Second: The applicant must complete 4 copies of the application and the green RBL-1 Form as well as the questionnaire. The application must be approved by the Chief of Police, after which all forms are brought to the Town Clerk's office. The Clerk's office must also receive two copies of Form 812 and a check payable to the Town of Westwood in the Amount of \$10.00

If all forms are completed and in order the Town Clerk will approve the application And issue a Permit

Please Note: If an organization has held a permit for a given year and does not intend to renew it the Form 812 must still be filed within 30 days after the expiration of the permit.
