I. OLD BUSINESS

A. TOWN UPDATE

Beth reported that the Town has been occupied with the following:

1. High Speed Wireless Internet Access

Kevin Joyce from Metricom presented their high-speed wireless Internet access network proposal. Metricoms' wireless network consists of wireless shoebox size radio transceiver /receivers (12 lbs) that would be mounted on 4% of the street lamp poles in the town of Westwood. The location of the receiver tower will be in Dedham. This service allows users to access the wireless network throughout the Boston Area. Westwood would be one town of many with this service. A nine city rollout is underway, including the City of Boston and Lynn. Metricom is looking for approval from the Information Systems Advisory Board and the Board of Selectman.

The Information Systems Advisory Board and the Cable Advisory Board see no objection in negotiating with Metricom. Leon Barzin will be drafting a proposal and will distribute to the Information Systems Advisory Board and the Cable Advisory Board for review. This proposal will then be forwarded to the Board of Selectman.

Below are some questions addressed at the meeting:

- Q: What is the effective range needed between street poles?
- A: Usually, every ¼ mile there would be a radio box mounted to the lamp pole. Metricom will perform a verification which will identify ideal pole locations.
- Q: Is there a frequency license required?
- A: No frequency license is required. The wireless network would be transmitted on the public frequency.
- Q: How does Metricom plan to market this product?
- A: Metricom currently has a contract with MCI.
- Q: What is the monthly cost for this service?
- A: The average monthly cost would be between \$65.00 \$110.00 per month. This may vary depending on the market and use.
- Q: How does the Town of Westwood benefit from this service?
- A: The town will receive ten free subscription for this service, as well as a 5% gross revenue paid to the town.
- Q: Is there data degradation or performance issues (speed, downtime)?
- A: The data will be transmitted on a T1 line and there should be no backlog of traffic.
- Q: What are the modem requirements?
- A: The only system requirement needed would be a wireless modem, which can be purchased through Metricom or any computer reseller.
- Q: Is there an exclusive contract with Metricom?
- A: No
