## Discussion Items-

- 1. Certificate of Compliance –DEP # 338-0221 75 Stanford Drive This project was done 20 years ago. The Engineering firm has gone out of business. You have the as-built but there is no letter from the engineer. I inspected the site on May 22, 2015. The project included a garage addition. There is a large pile of yard waste behind the fence. I would recommend you require the waste be removed before I issue the Certificate of Compliance and please let the owner know they must file for a building permit for the hot tub.
- 2. Scout project- Does anyone have any feedback on this project?

NOI – DEP #338-?- Westwood Cemetery, High Street – Present are Thomas Daley and David Crispin. Both were present at the last meeting for an informal discussion regarding improvements to the cemetery. Mr. Crispin states we have been working on cemetery projects for 30 years. Ms. Catrone flagged the location last fall. We will be altering approximately 1500 sq. ft of BVW. He demonstrates that this is a manmade pond. All towns must provide one or more spaces for their residents. In 1978 there was no pond. In 1980 the pond is shown. We cannot find an Order of Conditions so we believe this was done under a Request for Determination. He is aware of the 10 foot no touch but we plan to make improvements to the area. A presentation area with a cremation knock area is proposed. Fore bays and grass line swales are proposed.

Motion made by Mr. Rogers, seconded by Mr. Pare to approve the cemetery improvements proposed under this Notice of Intent. Unanimous.

NOI – DEP #338-0605 - 72 Deerfield Avenue – Deerfield School – Present is Todd Korchin, director of the Westwood Department of Public Works and Nicole Bands of the Recreation Department.
