Commissioning of the lighting system is scheduled for week of 1/4/16. <u>Technology Improvements</u> : An FM Hearing Assistance System and a portable flat panel television in the Community Room have been set up. <u>Staffing</u> : Andrea Varkas has accepted the part-time (20 hours) Library Assistant position in Circulation. <u>Performance reviews</u> : All completed. <u>Darien CT Library Field Trip</u> : On December 17 th , the library staff met with the staff of the Darien Public Library to exchange thoughts and ideas. It was a very successful interchange. <u>LSTA Grant Proposal</u> . Director Perry has requested a grant in the amount of \$7500 for Readers' Advisory, a program that provides for staff training in the use of electronic and print advisory tools, among other offerings. Proposal pending. <u>Budget Update - FY 16 and FY 17:</u> FY 16 budget is on track; and, FY 17 budget is now ready for FinComm review. <u>School/Community Collaborations</u> : Library staff in concert with Westwood High School will offer extended study hours for high school students during the mid-term exam period (January 19, 20 and 21). <u>Furnishings -Children's Room</u> : The Board unanimously voted
