#### Budget

Voters at the annual Town Meeting approved the FY 2013 library budget as submitted. The bottom line totals \$1,043,797.

## **Project Update**

The projected completion date for the project continues to be sometime in the fall. The Trustees discussed the scheduling impact of any delays. A meeting with TLT representatives was held to address scheduling issues and other project related matters. The PBC is controlling the project for the Town and is monitoring its schedule, budget and quality. The next PBC meeting will be the 2<sup>nd</sup> week of June in the Selectman's meeting room at 7 PM.

## Mover's Request for Proposal

Representatives from six moving companies attended the mandatory pre-conference for all prospective bidders. The movers will be responsible for library materials, office equipment, staff files, some shelving and special items such as the Town Seal and the Rufus Porter mural.

The Trustees reviewed a proposed draft of the new Meeting Room policy that will be in effect in the New Library. Suggestions were made and discussions occurred regarding use of the room. Tom Viti will revise the Policy for the next meeting of the Trustees.
