The presentation will be followed by Planning Board and public discussion, questions, and comments.
- 2. **215 High Street** Open Space Residential Development (OSRD) Special Permit Public Hearing -The Application proposes to construct fifteen (15) age-restricted single-family residential dwellings at 215 High Street as part of an open space residential development, a portion of open space is on 258 Grove Street. The application includes a consolidated EIDR\* and EMM\* review. This hearing was continued from 10/1/19 and 11/5/19. *APPLICANT HAS SUBMITTED A REQUEST TO WITHDRAW*
- 3. **141 Woodland Road, Eversource** EIDR\* Public Hearing. Proposal to demolish and replace existing natural gas gate station with two new prefabricated buildings, a filter station, and tie-in line.
- 4. **405 Nahatan Street** Earth Material Movement EIDR\* Public Hearing. Applicant proposes to import more than 200 cubic yards of earth material for the construction of a new single-family house.
- 5.85 Burgess Avenue Earth Material Movement EIDR\* Public Hearing. Applicant seeking retroactive approval for an earth material movement review for material brought in to re-grade the side and rear yard on residential lot.
