# MINOR MODIFICATION OF ENVIRONMENTAL IMPACT AND DESIGN REVIEW (EIDR) 240 UNIVERSITY AVE Map 38 & Lot 006

## February 26, 2019

The Planning Board of the Town of Westwood hereby **approves** the Minor Modification of the Environmental Impact and Design Review originally approved on January 8, 2019 by amending condition #1 by removing the prohibition for use of sodium chloride to allow de-icing by pretreating the surface with magnesium chloride followed by reduced sodium chloride application, as recommended by Dedham Westwood Water District (DWWD) as outlined in a letter from Mark E. Beaudry of Meridian Associates on behalf of Dacon Corporation dated February 14, 2019.

#### **BACKGROUND AND PROJECT SUMMARY**

The Applicant submitted an application for a minor modification to the previously approved Environmental Impact and Design Review (EIDR), which was originally granted by the Planning Board on January 8, 2019. The purpose of this minor modification is to remove the restriction prohibiting the use of sodium chloride as a de-icing or snow removal agent at 240 University Avenue. After the January 8, 2019 hearing, the Applicant received a recommendation from the Dedham Westwood Water District (DWWD) recommending the use of pre-treatment use of magnesium chloride followed by reduced sodium chloride in a memorandum from Weston & Sampson dated January 11, 2019.

The only modification associated with this request is to amend condition #1 of the Planning Board's January 8, 2019 EIDR approval strictly prohibiting any use of sodium chloride for snow or ice removal.
