#### I. GENERAL INFORMATION

Addendum 01 answers the following questions:

- Q1 In looking over the plans and specs. Drawing S1 is listed on the title sheet but is not included in the drawings. Is there a drawing S1?
- A1 **Add the attached drawing sheet S-1 to the Contract Drawing Set between sheets M-4 and E-1 as shown on the Cover Sheet List.**
- Q2 Will there be a site visit?
- A2 There will be non-formal pre-bid meeting. However, bidders will be allowed access to the site by appointment only on June 4, 2020, between the hours of 10:00 a.m. and 12:00 p.m. Potential bidders will be scheduled in 15-minute time slots to walk the site. No questions will be answered during the site visit. All questions shall be submitted in writing to the Town of Westwood's Procurement Office. - Q3 The spec is confusing regarding Insurance. The contract lists out insurances, but in the supplemental conditions it strikes out and deletes some of the insurances. Can you clarify what are all the insurance requirements for this project?
- A3 The insurance information from Section 00800 – Supplemental Conditions has been updated and the strikethrough for Sections 6.03 and 6.04 have been removed. **Remove "SECTION 00800 – SUPPLEMENTAL CONDITIONS" and replaced with the attach "SECTION 00800 – SUPPLEMENTAL CONDITIONS (REVISED ADDENDUM 1)"**

Addendum 01 makes the following changes, additions, and/or deletions to the Contract Documents (Plans and Specifications):

1. Section 11200-4, Item 1.5 Quality Assurance, Paragraph B:

**Delete "I-Series 4C3" and replace with "I-Series Model 4B2A"**

2. Section 11200-4, Item 1.7 Spare Parts, Paragraph A:

**Delete item numbers 3 through 8.**

3. Section 11200-13, Item 3.4 Warranty, Paragraph C:

**Revise last sentence to read, "The Manufacturer shall guarantee the equipment against defects of any kind for a period of one (1) years after final testing and acceptance."**
