


# (EARLY) VOTE BY MAIL PACKET

Every voter who requests an (Early) Vote-by Mail Ballot will receive one of following:

1. Instructions.
2. Ballot-If you are registered in a party, you will receive that party ballot, if you are Unenrolled (*formerly known as Independent*) you had to specify on your application what party ballot you wanted to receive otherwise you will not receive one until you contact us with your choice.
3. EV7 Envelope- Place cast ballot in this envelope that is marked with the voters name and address and sign on line 3. The ballot will not be accepted without the voter's signature.
4. AV8 Envelope-Place signed, sealed, EV7 envelope(containing your cast ballot) inside the pre-addressed, postage paid AV8 Envelope.



**PENALTY FOR ILLEGAL VOTING:**  
The penalty for voting in violation of section 24C of chapter 51A of the Massachusetts General Laws is a fine of not more than ten thousand dollars, imprisonment for not more than six months.
