**166 East Street, Norfolk Golf Club**

The Westwood Planning Board will hold a remote public hearing on **Tuesday, September 22, 2020 at 7:00 PM** via Zoom, regarding an application filed by Sean Sweeny of behalf of Norfolk Golf Club, for an Environmental Impact & Design Review (EIDR,) pursuant to Section 7.3 of the Zoning Bylaw for property located at 166 East Street. Applicant proposes to renovate the existing Golf Club by replacing the roof, siding, decks, windows and modifying front entrance, walkway and landscaping. The application also seeks to add a new exterior staircase for kitchen and lower lounge access at 166 East Street, also known as Assessor's Map 24, Lot 231. The property is located in the single residence C (C) zoning district.
