- Tennis Lessons (6 weeks); 128 registrations: \$7,800 profit
- Baseball Clinics (4 weeks); 139 registrations: \$4,700 profit

3 campers were sent home - all tested negative -

followed state guidelines for a successful summer program.

Rich wrap up - Sue, Brian and Sam - have done a great job in Aquatics. Kelley and Joe - equal amazing job for summer programs.

Rich sent out earlier today a compilation of parent emails with parents saying "Thank You" for the summer programs.

# **Aquatics update**

Sue - June works happened to meet guidelines and pool opened on July 6th.

Cancelled swim team

Added Life guarding and both classes were full

Pool - reservation system for lap swim and expanded to family swim.

Small group lessons - to maintain social distancing

Increasing our swim and conditioning program

Alternative plans for competitive swim

Underwater hockey - rugby and scuba diving

Offering again in the fall - Life guard training

Stretching class in ICC - Zoomed from home - 10 min socializing and 20 min stretching Locker room safety - Single flow of direction - assigned a lane - swim for allotted time and exit through locker no cross traffic

Added a COVID cleaner - credit to DPW for supplying with disinfectant

- a) Facilities Updates: HVAC system on Pool scheduled in September 2020
- b) Stats Report: Fiscal Numbers for 2020 page 12 (of the meeting packet)
  - Revenue increased by over \$33,000
  - \$45,000 more in profit from prior year.
  - Aquatics Flat comparing the 2 years
  - Combined up \$42,000

Lost 2 weeks of summer camp - 2020 - will show up in next fiscal year 2021

Renting summer fields - is up since last year.

## Other items not reasonably anticipated:

New Resident called about Pickle Ball - wanted to know if any progress?

On hold - a few years away from Pickle Ball

Asked to repurpose current Tennis court for Pickle Ball.

Tennis courts are in use at High School - more extensively than pre-Covid,

Mitch said that it wouldn't be wise to remove the tennis courts for pickle ball.

Recreation Commission believes the tennis courts are fully utilized and will consider the Sheehan section for Pickle Ball. When will the budget be available to Pickle Ball - town meeting 2022.

Ann noticed a group of boys on Flahive - playing lacrosse. A group of 25 boys - was field permitted?
