**NOTICE OF PUBLIC HEARING**  
**25 Phillips Way**

The Westwood Planning Board will hold a remote public hearing on **Tuesday, December 1, 2020 at 7:00 PM** via Zoom, regarding an application filed by Dan Merrikin, for an Earth Material Movement (EMM) Environmental Impact & Design Review (EIDR) pursuant to Sections 7.1 and 7.3 of the Westwood Zoning Bylaw at the property located at 25 Phillips Way.

The Applicant is proposing to import 100 cubic yards of fill and export a total of approximately 700 cubic yards of earth material to re-grade the property for the construction of a new single family residence at 25 Phillips Way, Westwood, MA 02090 also known as Assessor's Map 39, Lot 029. The Planning Board will be reviewing the transportation of earth material to and from the property. The property is located in Single Residence C (SRC) zoning district.
