IMPLEMENTATION

The following tables summarize the 230+ implementing actions proposals taken from the various Plan elements. Listed is a brief statement of each proposal, the Plan element from which it is taken, the suggested lead agency, and the period in which the action is scheduled be undertaken. The primary purpose is to compile recommendations and provide a sense of their timing to be used by town staff, boards, and the responsible entities. This should be used as a guide to direct efforts and as a way to annually document progress and provide comments on what, how, and when for each action item. This Plan does not allocate any specific funding or make financial commitments but serves as a policy guide for the community.

An "Ongoing" indicates the action is already in progress, underway and may have been started prior to final completion of this Plan, or that it is something that should be done on a regular basis. A "Short Term" means at least initiated within the short term within two years; "Mid-Term" means within three to five years, and "Long Term" means longer than five years given the timing involved. While the Committee feels all items are important there are some recommendation actions that take longer than others due to a regulatory process or multiple agency involvement. Thus, some of the short term items may be less time consuming and may begin relatively quickly. There is a column labeled "High Priority" that identifies the actions that respond to the major recommendations to focus efforts or in need of improvement expressed throughout this process.

The challenge of addressing this demanding agenda inevitably falls most heavily on the Select Board and Planning Board, but others also are called upon to do a great deal. Keeping up with the schedule as laid out will call for careful priority setting and coordination among groups.

To assure sound implementation of this broad agenda, ongoing coordination and direction will be needed. Westwood has a strong tradition of Town organizations working closely together, and now has the staff and organizational structure to make the effort work.

These actions listing reflect not just the judgement of the Comprehensive Plan Steering Committee or the Planning Board, but the concurrence of the many organizations whose efforts would be involved and who have reviewed and made suggestions on this Plan. Gaining that concurrence took some time but was worth pursuing. The Plan represents the collective intentions of the agencies and officials involved, as well as that of the broad array of citizen participants in the planning process.

The responsibility for Plan adoption lies with the Planning Board, responsibility for ongoing monitoring of progress and providing coordination also lies with the Planning Board. The present intention is that the Board will annually provide Town agencies and others listed in the Implementation table with a listing of actions scheduled for their efforts over the past year and the forthcoming one. Plan updating and revision is of critical importance. Planners frequently suggest that a comprehensive plan is updated every five to ten years. An update generally takes two years to complete, therefore, this plan recommends beginning the update process in seven years (2027).
