The Planning Board will introduce and give an initial overview of the zoning articles submitted for this year's Annual Town Meeting warrant.

<u>Planning Board Article 1</u> - Amendments to Temporary Uses & Structures Section 4.1.7.4 <u>Planning Board Article 2</u> - Amend Section 4.1.5.41 to prohibit Fire Arms and Explosives Sales in Local Business A (LBA) & Local Business B (LBB) zones

<u>Planning Board Article 3</u> - Amendments Relative to defining [Definitions Section 2] and regulating where various medical uses are permitted and prohibited [Table 4.1.2 Table of Principal Uses]. Amend Zoning Map to establish new Medical Facilities Overlay District and set new special permit criterial in new Section 9.8 for Medical Facility Overlay District]. Planning Board Article 4 - Housekeeping - to correct any non-substantive errors.
