### WESTWOOD PLANNING BOARD NOTICE OF PUBLIC HEARING 25 Clapboardtree Street & Abbey Road

The Westwood Planning Board will hold a remote public hearing on **Tuesday, February 23, 2021 at 7:00 PM** via Zoom, regarding an application filed by Westwood Green LLC for a Special Permit, pursuant to Section 8.3 [Open Space Residential Development (OSRD)] of the Westwood Zoning Bylaw. The Application proposes an amendment to the OSRD Special Permit approval granted on April 23, 2019 including the consolidated Earth Material Movement Environmental Impact Design Review for the new Abbey Road condominiums, pursuant to Section 7.1 and 7.3 of the Zoning Bylaw.

The amendment proposes to add three senior residential units on the parcel adjacent to the Homes at 45 at 25 Clapboardtree St (Lot 2) previously proposed as a single-family home. The new units are proposed to be combined with the condominiums at the Homes at 45 on Abbey Road (FKA 45 Clapboardtree St.). The subject property is located at 25 Clapboardtree Street, Westwood, MA 02090 also known as Assessor's Map 29, Lot 199 and proposed work to be combined with Lot 7 on Abbey Road. The property is located in Single Residence C (SRC) zoning district.
