<u>Article 1</u> - Zoning Amendments Relative to Property on High St. in vicinity of Obed Baker

House. - This article is expected to be withdrawn and no action was taken by the Planning Board.

<u>Article 2</u> - Zoning Amendment Relative to Temporary Uses & Structures to allow an administrative process for short term proposals.

<u>Article 3</u> - Zoning Amendment Relative to Prohibiting Fire Arms & Explosives sales in the Local Business A (LBA) and Local Business B (LBB) zones.

<u>Article 4</u> - **4a** - Zoning Amendment Relative to Medical Uses - Medical Centers or Clinics and Offices of Health Care Professional

4b - Prohibiting Hospitals in all/any zoning district

4c - Creating new Substance Rehabilitation Facility Overlay District

<u>Article 5</u> - Zoning Amendments Relative to Housekeeping. No substantive changes only to correct errors and typos.
