# NOTICE OF PUBLIC HEARING 710 & 722 High Street

The Westwood Planning Board will hold a remote public hearing on **Tuesday**, **April 6**, **2021 at 7:00 PM via at Zoom**, regarding an application filed by Global Montello Group Corp. for an Environmental Impact and Design Review (EIDR), pursuant to Section 7.3 of the Westwood Zoning Bylaw to redevelop and merge the properties at 710 & 722 High Street, Westwood, MA 02090 also known as Assessor's Map 14, Lots 128 & 130. The properties presently consist of two service stations, a retail building, parking, and fuel pumps. Applicant proposes to demolish the two dispenser service station and building at 722 High Street; expand the retail building at 710 High St. with a 1,718 SF addition; expansion of existing canopy for additional fuel pump; construction of 24 off street parking spaces, and associated site improvements. The property is in the Local Business A (LBA) zoning district.
