Public Comment:

Alex Yale - 22 Hedgerow Lane - wants Pickle Ball courts at Downey School. Each tennis courts will give 2 Pickle ball courts.

Group of Westwood men play at Savage Rec Center in Norwood

Jason Denmark - 53 Highview St. supports Alex. Pickle ball is very popular and now at Kingsbury in Medfield and at Millis High School.

Kyle Dow - 29 Hedgerow Lane - supports Alex Nick Mann - 28 Pheasant Hill - supports Alex

Peter Lutz - 132 Church St - supports Alex

Resurface courts to add colored lines @\$350 per court and looking for 4 courts - total is \$1,400 Purchase nets - \$250 per pickle ball court. Alex is looking for lines only and not nets.

a) **Examples of Town Signage** - Paul and Sheila to complete surrounding town signage by next meeting.

Tennis courts signage - conversation with Chris Coleman. Preference for Westwood residents - could be conflicts. If not Westwood resident - fear of confrontations. Time restrictions - suggested 1 hour.

Paul looked in Needham - signs for Covid and distancing. Tennis court at high school - need badge to play on court.

Recommendation: Update signage on tennis courts - limit 1 hour of playing if others are waiting. Add this to Downey courts as well.

Paul shared signs from Needham.

Rich will look into signage for Covid and check with Ken Aries on fields with schools.
