1. 8 Windmill Lane

Application requests a variance pursuant to the Westwood Zoning Bylaw Sections §4.5.3.3[Variance Required for New or Expansion of Nonconformity]. The application proposes to construct a garage that encroaches into the rear yard setback. The property is located in the SRC (Single Residential C) zoning district.

2. 26 Gay Street

Application requests a special permit pursuant to the Westwood Zoning Bylaw Sections §4.5.3.2 [Special Permit Alterations of Nonconforming Structures]. The application proposes to construct a second story dormer addition that would raise the height in the side setback. The property is located in the SRC (Single Residential C) zoning district.

3. 33 Hooper Street

Application requests a special permit pursuant to the Westwood Zoning Bylaw Sections §4.5.3.2.2 [Special Permit Alterations of Nonconforming Structures]. The application proposes to construct a second story dormer addition that would raise the height in the side setback. The property is located in the SRA (Single Residential A) zoning district.

4. 213 Hartford Street

Application requests a special permit pursuant to the Westwood Zoning Bylaw Sections §4.3.3.2 [Accessory Uses – Motor Vehicle Storage]. The application proposes to store 4 or more motor vehicles on the subject property. The property is located in the SRC (Single Residential C) zoning district

5. 420 Providence Highway

Application requests a special permit pursuant to the Westwood Zoning Bylaw Sections §6.2.15 [Signs - Special Permits]. The application proposes to install a total of six (6) signs that exceed the maximum allowable number and area. The property is located in the HB (Highway Business) zoning district.
