NOTICE OF PUBLIC HEARING 808 High Street

The Westwood Planning Board will hold a remote public hearing on **Tuesday, May 18, 2021 at 7:00 PM via at Zoom**, regarding an application filed by Crown Castle on behalf of AT&T and T-Mobile for a Wireless Communications Overlay District (WCOD) Special Permit pursuant to Section 9.4.5.4 and Section 7.3 [Environmental Impact & Design Review] of the Westwood Zoning Bylaw. Application proposes to construct a new 100' flagpole style monopole that can accommodate ATT and T-Mobile antennas and ancillary equipment inside the new pole. Ground work to include adding a diesel generator on a new concrete pad, equipment shed on a new concrete pad and fiber/electric in an expanded compound area. The existing flagpole wireless facility located at 808 High Street, Westwood, MA 02090 also known as Assessor's Map 14, Lot 140 will be removed after construction of new facility is completed. The facility is located in the Single Residence E (SRE) zoning district and Wireless Communications Overlay District (WCOD), and the front portion of the lot is in the SRC zone.
