See G.L. c.30A, § 21(a)(7)
- Pursuant to G.L. c.30A §22(f) (g) to comply with any general law for review of Executive Session Minutes, all of which would have a detrimental effect on the position of the governing body if discussion were in open session. The Board will not be returning to open session.
- Adjournment of public meeting
