NOTICE OF PUBLIC HEARING 3, 6, 9 Recess Way

The Westwood Planning Board will hold a public hearing on **Tuesday, June 29, 2021 at 7:00 PM, in the Champagne Meeting Room at 50 Carby Street, Westwood, MA 02090**. This meeting is being scheduled as an in-person meeting at the Carby Street Municipal Building as the COVID protocols for remote meeting participation will end on June 15, 2021 unless extended by the state. If it is extended, the meeting may be changed to a combination in-person and remote or just a remote meeting. Application is filed pursuant to the Board's Rules and Regulations Governing the Subdivision of Land and the Westwood Zoning Bylaw Section 8.3.16.3 for Open Space Residential Development-Environmental Impact and Design Review. Proposed modification is for proposed drainage changes at the subdivision at 3, 6 & 9 Recess Way, Westwood, MA 02090 also known as Assessor's Map 03, Lots 028, 029 & 030. All lots are located in the Single Residence C (SRC) zoning district.
