The Westwood Planning Board will hold remote public hearing on **Tuesday, August 17, 2021 at 7:00 PM** regarding an application filed by Westwood Pavilion, LLC for an Environmental Impact and Design Review (EIDR), pursuant to Sections 7.3 and 7.1 for Earth Material Movement of the Westwood Zoning Bylaw for parking expansion and drainage improvements at 100 High Street, Westwood, MA 02090 also known as Assessor's Map 06, Lot 019. Applicant proposes to construct new parking area to add 37 parking space in the undeveloped area in the rear. Application requests waiver from Section 6.1.8 [Maximum Parking Requirements] to exceed the maximum parking requirements. The property is in the Administrative-Research-Office District (ARO) zoning district.
