## **Call To Order:**

The meeting was called to order at approximately 5:30 pm by Chairman, John Cronin, Jr. All attendees participated remotely.

## **Chairman's Update:**

Mr. Cronin was present, and discussed that the project is very close to substantial completion, next Friday. Sean Sweeney and Steve Brown are leaving Arcadia, but will stay on as consultants. Arcadis will leave money in the project, the State and Town should be good with it, and will have \$20,000 left for our contingency. Mike McKay and Jimmy McCarthy from Town will help out with work that needs to get done in July. With OPM work being done, work left is considered at about \$130,000 which will go towards the Change Orders 8 & 9.

After paying Tower tonight, we will have about \$580,000 left, probably \$525,000 when we meet in July, and about \$50,000 left in the contract for the August meeting. The Town needed to come up with additional funds, the Morrison Project, there was some money available, about \$480,000 used \$275,000 for the bidding process, which then left us with about \$200,000 for potential Change Orders and FF&E. The project will need money from the Morrison Budget, and \$150,000 has been released to the project, which will leave about \$130,000 going forward for FF&E.

### Wentworth Hall – OPM Update:

Steve Brown was present to discuss bidding the project last summer with some funds available to be able to award a contract. A very detailed project. A lot of the costs being reviewed are as transparent as possible.

## Comments:

• Do we have permanent power? Mr. Brown: Yes, as of last night.

- Walked through this afternoon, have any of the mechanicals been started up? *Mr. Brown: Mechanical start up is scheduled for Monday.*
- The elevator? Mr. Brown: Work is complete but waiting for an elevator inspection date. Mr. McKay: It's not complete, but it is running, they needed permanent power. Walk through with the inspector on Monday. It was delayed 3 weeks.
- Does it make sense to push through on total completion? Warranties start, what is the benefit to the Town? *Mr. McKay: It will only happen next week if it is ready. Planning on punch list Goal is to shoot for next Friday. Walk through on Thursday.*
- Mr. Cronin: The goal is Friday, implied if it works.
- Seemed like the basement was very humid and the elevator slab was wet. *Mr. McKay: It is because there is no air conditioning. We have been running fans. It is a concern since the building has been sealed up.* Hard to gauge without the mechanical systems running. The basement is a concern.
- Mr. Cronin: Tower will be on the project until July.
- Parking lot up the hill, by the security company, a portion of it drains into a corner of the site, which adds to a potential problem in the basement. *Mr. McKay will look into it.* There is a Cape Cod berm that runs along the side of the parking lot, the water rushes into the site. *Mr.McKay will take a look at it.*

Mr. Brown continued with the budget update, Tower wants to finish up the job, there is still a substantial amount of money left. We have a contract with Tower of 6/1 substantial completion. Tower is motivated to stay and wants to finish with good publicity. Meeting in July will capture costs for June.

## Final Comments:

- Mr. Coghlin offered to help out Mr. McKay set the right expectations.
- Do we have a Temporary Certificate of Occupancy or are we waiting for the Full Certificate of Occupancy? *Ms. Loughnane: At best you will get a Temporary Certificate of Occupancy.*
- Ms. Loughnane: There are 2 pending Change Proposals: The Oil Water separator, under \$60,000 and a change proposal for a credit for Hydroseeding for less than \$400. Any questions about the 2 proposals? *Mr. Cronin: As it relates to the credit of hydroseeding, credit from Tower landscaping, we will reject the credit or give a larger credit. The Town does it just as well, and there is a timing issue too, not until late September.* Loam spread was not seeded? *Ms. Loughnane: No, it's all weeds.*
- Mr. Brown: The CCD issued for the oil water separator for the elevator they encountered ledge. And could not make a recommendation tonight, did not have enough time. Additional \$11,892.22 closing out of the storage tank, still under the budget number. Did not have enough time to go through. And the credit for the hydroseeding. Will vote on in July.
- Mr. Brown: Exterior lights (to meet code and occupancy), painting and the foldable participation for lower level, want to exclude it from the projections, and do it outside of the project budget. *Ms. Loughnane: No, it is all in the project budget.* The Town is intending to do this work. *Ms. Loughnane: One of the conditions in getting the additional \$150,000 in contingency was to include those amounts. \$25,000 for the room divider, \$7,500 for the exterior lights and \$5,000 for the painting, it has to be kept in the budget.*
