The Westwood Planning Board will hold a remote public hearing on **Tuesday, October 12, 2021 at 7:00 PM via at Zoom**, regarding an application filed by Gail Mann for an Earth Material Movement (EMM) Environmental Impact Design Review (EIDR), pursuant to Sections 7.1 and 7.3 of the Westwood Zoning Bylaw. Applicant proposes regrading and earth work to construct a barn at 126 Skyline Drive. The proposed regrading will result in finished elevations of 5 feet or more above surrounding grades located at 126 Skyline Drive, Westwood, MA 02090 also known as Assessor's Map 02, Lot 007. This property is located in the Single Residence C (SRC) zoning district and presently contains a single-family residence and a shed.
