A Message from the Chair – Dianne McCarthy

As the Finance and Warrant Commission (FinCom) prepares for the 2021 Special Town Meeting to be held on October 18, 2021, I would like to invite Westwood residents to learn more about the role of the Commission and participate in our upcoming public hearing, scheduled for September 20, 2021.

The FinCom is a fifteen members Commission whose members are appointed by the Town Moderator to serve three-year overlapping terms. In accordance with the Town Charter, the Commission:

- Considers all articles in Town Meeting Warrants and reports in print its advice, estimates, and recommendations to residents.
- Studies the financial and other affairs of the Town and advises with officers of the Town as to expenditures and recommendations for appropriations.

Preparations to address the Special Town Meeting warrant article(s) commenced in January of 2018 when the School Committee first came before FinCom with a warrant article to request funding for the initial MSBA feasibility study for the Paul Hanlon Elementary School grant eligibility process. (Please see Page 5 for more details on the Elementary School Building Project Timeline.) As a Commission, we educate members through workshops and presentations made by various representatives in Town; monitor budgets approved at the previous Town Meeting; and receive information on possible articles for the upcoming Town Meetings. Members of the Commission engage in a thorough review of the Town Meeting warrant articles. Each article sponsor comes before the Commission to discuss their article at least once.

For the Special Town Meeting, the FinCom has scheduled one public hearing on September 20 which is devoted to discussing the important issues on which residents will vote at the October 18, 2021 Special Town Meeting. The hearing is intended to provide residents the opportunity for public participation and input into matters facing our Town. At this meeting and during additional FinCom meetings, members of the Commission are apprised of the intent, background and details of each article. Through sponsor presentations, member questions and input received from the public, Commission members determine their position and formulate recommendations on the article(s). Following public input, the FinCom will vote their recommendation(s) at the public hearing on September 20.

The FinCom urges your participation at our **upcoming public hearing on September 20** and at the Special Town Meeting on October 18, 2021.

School Committee-1: Elementary Schools Building Project

This article is intended to see if the Town will vote to appropriate, borrow or transfer from available funds, an amount of money to be expended under the direction of the School Building Committee to pay costs of design, constructing, equipping, and furnishing a new Paul R. Hanlon Elementary School, which will consolidate the current Hanlon Elementary School and the Deerfield Elementary School, to be located at 790 Gay Street, in Westwood, Massachusetts, including costs of site work and all other costs incidental and related thereto.
