## **Chairman's Update:**

Mr. Cronin was present to announce that Wentworth is complete. He was proud about how we ended this project with a lot of time and budget to balance. He noted that tying a public building into a total redevelopment of a neighborhood was tricky for everyone involved. He thanked everyone on the Zoom call for all the work they have done.

Mr. Cronin presented 4 invoices to approve: Sanibel Electrical, Ace Locksmith, McKay Architects (who has deducted some of his pay for some work that needs to be done to install 2 glass interior doors), and Tower requisition.

He noted that 3 Wentworth Hall doors still need to be painted by the Town and confirmed that Tower completed the seeding. Jim McCarthy is still waiting for quotes on replacements for 2 entrance door locks and an installation of a room divider. All of the work is all included within the project budget with place holders.

Mr. McCarthy was present and said he received all of the close out documents fromTower Construction. The final punch list issues are all set. Tower is 100% complete, the paperwork for systems meets with his satisfaction.

### **Board Comments:**

- The lawn, will the Town take over? Mr. McCarthy: Yes, it's hydroseeded and we will see what happens in the spring.
- Not worried? Mr. McCarthy: No, not much of a grass area, we can fix any issues in-house in the spring
- Do we have a final Certificate of Occupation? Ms. Loughnane: Still have a conditional C of O.
- Is it conditional on the electrical on what the Town is doing? Ms. Loughnane: Yes, she thinks so.

- Did the Comcast issue get resolved with the wet lines? Mr. McCarthy: Yes, it has been addressed and is no longer an issue.
- Were there some electrical repairs, rusted outlets? *Ms. Loughnane: The one outstanding concern is whether we will get a full warranty on the floor box outlets, still waiting on the paperwork.*
- How many outlets are involved? Mr. McCarthy: 4 floor boxes in the basement. Comcast has made a commitment to Tower to cover whatever is necessary to get that warranty. So if they have to retire the outlets, they will, but it has not been done yet. Patrick Fitzgerald, from Tower, is working on the warranty from the electrician.
