#### **I. General Information**

Addendum 01 extends the bid due date until **10:00am on February 24, 2022**.

Addendum 01 also answers bidder questions.

**Q1** Can the voting system use a 3<sup>rd</sup> party platform?

**A1** For security and reliability, software used for clicker voting should not live inside a 3<sup>rd</sup>-party platform such as Microsoft PowerPoint, Prezi, Sequel. The Town may reject any solution that is not a standalone application for security reasons.  
Software that is designed to be an “add-in” to a primary application such as PowerPoint may suffer from updates and changes to the primary application that you cannot control.

**Q2** What is the required receiver coverage?

**A2** Long Range Receivers must have a 600 x 600 square foot range and provide 360,000 square feet of coverage.

**Q3** Are bidders required to include annual maintenance or operating fees?

**A3** Bidders are required to include any maintenance, operating fees, subscriptions, etc. that are required to maintain the system. The Bid Form is updated to include those costs for the first three years.
