NOTICE OF PUBLIC HEARING**

The Westwood Select Board will hold a remote Public Hearing on Monday, July 11, 2022, at 6:00 pm, pursuant to Chapter 20 of the Acts of 2021. On June 16, 2021, Governor Baker signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency and this Act includes an extension, until July 15, 2022, of the remote meeting provisions of his March 12, 2020, Executive Order.

Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real-time, via technological means. In the event that we are unable to do so, for reasons of economic hardship and despite our best efforts, we will post on the Town website an audio or video recording, transcript, or other comprehensive records of proceedings as soon as possible after the meeting.

The meeting will be filmed live by Westwood Media Center and available for viewing on Comcast channel 12 and Verizon channel 42.
