**NOTICE OF PUBLIC HEARING**

**Public Right-of-Way in front of 461 Sandy Valley Road**

The WESTWOOD TREE WARDEN will hold a public hearing in conjunction with the WESTWOOD PLANNING BOARD on **Tuesday, August 9, 2022 at 7:00 pm** in the Champagne Meeting Room within the Carby Street Municipal Office Building, 50 Carby Street, Westwood, Massachusetts 02090, regarding an application filed by the Town of Westwood Department of Public Works requesting permission for the removal of a dead or dying 20 - inch (20" ) White Oak tree located within the public right-of-way of Sandy Valley Road in front of 461 Sandy Valley Road for safety reasons. Application filed pursuant to Westwood Planning Board Scenic Road Rules & Regulations and M.G.L. Chapter 40 Section 15C [Scenic Roads Law].

Land affected: Public right-of-way in front of 461 Sandy Valley Road, also known as Assessor's Map 15, Lot 010. The tree proposed for removal has been tagged with a ribbon and a copy of this hearing notice has been placed on the tree.
