The WESTWOOD TREE WARDEN will hold a remote public hearing in conjunction with the WESTWOOD PLANNING BOARD on **Tuesday, August 9, 2022 at 7:00 pm via Zoom**. Pursuant to Chapter 20 of the Acts of 2021, An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency, signed into law by Governor Baker on June 16, 2021, and including an extension until March 31, 2023, of the remote meeting provisions of his March 12, 2020, Executive Order, this public hearing will be conducted via remote means. The application filed by the Town of Westwood Department of Public Works requests permission for the removal of limbs of a White Oak tree located within the public right-of-way of Canton Street in front of 170 Canton Street for safety reasons. Application filed pursuant to Westwood Planning Board Scenic Road Rules & Regulations and M.G.L. Chapter 40 Section 15C [Scenic Roads Law].

Land affected: Public right-of-way in front of 170 Canton Street. also known as Assessor's Map 25, Lot 063. The hearing notice will be placed on the tree proposed for limb removal.
