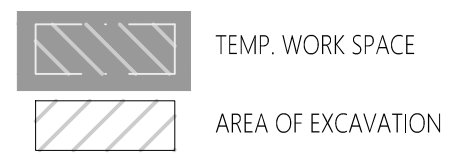


General Notes
