PM via at Zoom, regarding an application filed by T Mobile Northeast c/o SAI for a Wireless Communications Overlay District (WCOD) Environmental Impact Design Review (EIDR) pursuant to Sections 7.3 and 9.4 of the Westwood Zoning Bylaw for the purposes of upgrading equipment at an existing wireless communication facility. The application proposes to modify the existing installation at the Property by removing nine (9) antennas of the existing twelve (12) antennas and replacing them with nine (9) upgraded antennas that will be attached to the existing mount pipes and replacing all nine (9) existing RRHs with updated models. The project will also entail replacing existing cables.
