The Westwood Planning Board will hold a remote public hearing on **Tuesday, September 6, 2022 at 7:00 PM via at Zoom**, regarding an application filed by Lisa Lowrie for an Environmental Impact Design Review (EIDR) pursuant to Section 7.3 of the Westwood Zoning Bylaw. The project proposes the installation of a wooden fence enclosure around the dumpster at the dock door located at 345 University Avenue Westwood, MA 02090 also known as Assessor's Map 37, Lot: 13. An existing commercial building is currently on the property and it is located in in the Industrial (I) and Flexible Multiple Use Overlay District (FMOUD) zoning districts.
