

Rating Action: Moody's assigns Aa1 issuer rating to Westwood, MA

New York, August 22, 2022 -- Moody's Investors Service has assigned a Aa1 issuer rating to the Westwood Town, MA. Moody's also maintains a Aa1 rating on the town's outstanding general obligation limited tax (GOLT) debt. The issuer rating is equivalent to the town's hypothetical general obligation unlimited tax (GOULT) rating, there is no debt associated with this security. The town has about \$91.5 million general obligation debt outstanding.

RATINGS RATIONALE

The Aa1 issuer rating reflects the town's sizeable tax base with strong resident income and wealth levels and improving financial position. Despite the recent issuance of school bonds, the town's long-term liabilities and fixed costs remain manageable.

RATING OUTLOOK

Moody's typically does not assign outlooks to local government credits with this amount of debt outstanding.

FACTORS THAT COULD LEAD TO AN UPGRADE OF THE RATING

- Material increase in reserves and liquidity
- Significant reduction of long-term liabilities

FACTORS THAT COULD LEAD TO A DOWNGRADE OF THE RATING

- Material deterioration of the reserves and liquidity
- Significant increase in debt or other long term liabilities
- Deterioration in tax base or income and wealth levels

LEGAL SECURITY

The issuer rating reflects the implied general obligation unlimited tax pledge of the town. Westwood's outstanding bonds are payable from the town's full faith and credit general obligation limited tax pledge given that not all of the debt service has not been voted by the town as excluded from the tax levy limitations of Proposition 2 1/2.

PROFILE

The town is favorably located approximately 13 miles from Boston (Aaa stable) in Norfolk County (Aa3). The town has approximately 16,000 residents.
