**PLANNING BOARD****NOTICE OF PUBLIC HEARING**  
**436 Washington Street**

Pursuant to Chapter 20 of the Acts of 2021, on June 16, 2021, former Governor Charles Baker, signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency. This Act includes an extension, until March 31, 2023, of the remote meeting provisions of his March 12, 2020, Executive Order. This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. In the event that we are unable to do so, for reasons of economic hardship and despite best efforts, we will post on the Town website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting.

The Westwood Planning Board will hold a remote public hearing on **Tuesday, February 7, 2023 at 7:00 pm via Zoom**, regarding an application filed by Peter Zahka, on behalf of Stephen T. David, Trustee of 436 Washington Street Realty Trust, for a Flexible Multiple Use Overlay District (FMUOD) Special Permit pursuant to Section 9.5 of the Westwood Zoning Bylaw for the purposes creating a new mixed-use development by adding a second story to an existing commercial structure and undertaking associated site alterations, including parking, drainage, lighting, and landscaping improvements. The resultant structure will contain approximately 3,275 SF of office space on the ground floor and five 1-bedroom apartments on the second floor at 436 Washington Street, Westwood, MA 02090. The property is in the Local Business B (LBB) zoning district and within Flexible Multiple Use Overlay District 6 (FMOUD6).

Land affected: Assessor's Map 23, Lot 224. Property Owner: Kenneth Sliby/Sliby Family Trust.
