# **Board of Selectmen Sponsored Articles**

# A. Blue Hills Technical Regional School District - Renovation Project

This article is intended to present and request support for the Blue Hills Regional Technical School \$85 million renovation project.

# B. Gay Street Sidewalk Design Funding

# F. Interim Office Space - Town Hall and/or Carby Street

This article is intended to serve as a placeholder for the Municipal Facilities Task Force as it goes through the analysis of the space needs of the municipal departments.

- G. Municipal Facilities Conceptual Planning This article is intended to serve as a placeholder for the Municipal Facilities Task Force to seek the appropriation of funds to design conceptual plans for the renovation of municipal office spaces, main fire station, senior center and/or recreation and youth and family services offices, etc.
- H. Accounting Housekeeping Establish Account for Meals/Hotel Tax

This article is intended to establish in accordance with MGL Chapter 40. Section 5B, a special purpose meals tax account.

# I. Accounting Housekeeping - Establish Account for School Special Education Reserve

This article is intended to accept MGL Chapter 40, Section 13E, which establishes a reserve fund to allow the School Department to pay for unanticipated or under budgeted costs of special education, out of district tuition and/or transportation.

# M. Zoning Amendment to Limit Number of Residential Dwelling Units in FMUOD6 & FMUOD7 (co-sponsor - Planning Board)

This article is intended to add a definitive cap on the number of residential dwelling units which may be constructed by special permit within the Washington Street and High Street Flexible Multiple Use Overlay Districts (FMUOD6 and FMUOD7). The purpose of this article is to limit the total number of residential dwellings that could be approved by Planning Board special permit.

# N. Zoning Amendment Related to Accessory Uses in Highway Business

This article is intended to allow accessory uses such as cafeterias, snack bars, gift shops, and vending machines within buildings in the Highway Business (HB) zone, where such uses are currently prohibited. The Planning Board is sponsoring this article for fall Town Meeting at the request of a property owner who is currently marketing available office space.

#### O. Zoning Amendment Related to Medical Uses

This article is intended to revise Zoning Bylaw provisions related to medical uses. The purpose of this article is to clarify distinctions among various types of medical uses and to specify where those uses may be permitted in Town. The Zoning Bylaw presently references differing terms for medical uses, some of which are not clearly defined and some of which are not presently included in the Use Table.

# P. Housekeeping - Zoning Articles

This article is intended to make necessary amendments to various sections of Zoning Bylaw and/or Zoning Map to correct any errors or inconsistences which may be discovered during the public hearing process.
