On March 29, 2023 Governor Maura Healey signed into law, the Acts of 2023, which includes an extension to pandemic related authorizations related to public meetings. The petitioner proposes to construct an accessory apartment addition attached to the rear of an existing single-family home. The property is located in the SRC (Single Residential C) zoning district.
