- a) Summer Registration started. High number of registrations. Recreation has started summer hiring
- b) Aquatics Manager re-elected at Aquatics Representative of MRPA
- c) Field scheduling is completed and permits going out this month
  - a. Fields scheduled to open April 1st

- a) February 27 (Spring Registration) Activity Reg Disruption
  - O Reviewed software failures communicated from Peak Software
- b) Spring Registration Update
  - Registrations approx 10% higher on the first day
- c) Summer Registration Update
  - Growth in total income over the first 4 days of registrations compared to 2022
  - O Slight decline in total registrations over the first 4 days of registrations compared to 2022
  - Expanded programming by offering more programming but also more availability within the program
- d) Summer Hiring Update

- e) Fields/Facilities
  - o Pool Deck Resurface Update
    - i. Resurfacing is underway. Timeline shows tiling will start next week.
    - ii. Project is on schedule
  - o Pickleball Update
    - i. Issue with site: drywell in center of court. Would need more grading to level the area.
  - School Street Playground Update
    - i. Rich met with DPW Facilities Manager and Playground Installer
    - ii. Planning on May 15th playground construction
    - iii. Playground will be closed for 4 weeks
    - iv. Installing two inclusive features
    - v. Removing mats and replacing with poured rubber
    - vi. Replacing other features that are weathered
    - vii. Fully funded through American Rescue Plan (ARP) and some from the town to repair fence, pavilion, and fix tree roots.
