## **ACTION ITEMS:**

- The Fiscal Year 2024 (FY24) compensation plans were presented to the Board for approval. Molly Kean stated that a cost of living adjustment (COLA) is based on the Town's budget and, in part, on what other communities are doing. She also made the following comments with respect to each of the compensation plans:
  - The Select Board approved a 2.5% COLA for all non-union ATP and Library ATP positions which was factored into the FY24 salaries in the respective compensation plans.
  - The Police Lieutenant position was removed from the ATP Compensation Plan (Grade 14) and a separate Police Superiors Compensation Plan was created by agreement between the Town of Westwood and the Westwood Police Superior Officers Association. Westwood currently has two Police Superiors.
  - Positions on the Part-Time Seasonal and Other (PTSO) Compensation Plan were adjusted to remain competitive with neighboring communities. DPW Seasonal Laborer positions were added to this compensation plan.
  - The Recreation Part-Time Seasonal and Other (PTSO) Compensation Plan reflects a 2023 calendar year change in Massachusetts Minimum Wage and incorporates competitive rates for seasonal positions based on other communities.
  - As of the date of the Personnel Board meeting, the Fire, Police, Public Works and Clerical Unions had not settled their FY24 contracts, therefore, rates for FY24 remain consistent with FY23 rates.
