The Board shall hear an application filed by Jan Gleysteen Architects for a Special Permit pursuant to the Westwood Zoning Bylaw Sections §4.3.3.2 [Accessory Uses – Motor Vehicle Storage]. The Petitioner proposes to construct a two-story addition which will include a two-car garage. There is an existing attached three car garage on the property. The proposed additional garage bays will result in parking or storage of more than three (3) motor vehicles. The property is located in the SRE (Single Residential E) zoning district.
