NOTICE OF PUBLIC HEARING 80 University Avenue (Meketa)

Pursuant to Chapter 20 of the Acts of 2021, on March 29, 2023, Governor Healey signed into law An Act Extending Certain COVID-19 Measures Adopted during the State of Emergency. This Act includes an extension, until March 31, 2025, of the remote meeting provisions the previous administration's March 12, 2020, Executive Order. This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. The Westwood Planning Board will hold a remote public hearing on **Tuesday, September 12, 2023 at 7:00 p.m. via Zoom** regarding an application filed by Ericka Winchester on behalf of Ready 2 Run Graphics & Signs for consideration of a Project-Specific Signage Alternative Approval pursuant to Section 9.7.10 of the Westwood Zoning Bylaw for the purposes of installing two (2) 6" wide x 4" tall intercom wall signs – one (1) of which will be on the interior the building and the other on the eastern exterior facade, one (1) 32" wide x 24" tall (36" x 42" when mounted) non-illuminated post-mounted wayfinding sign in the rear parking lot, and one (1) 24" wide x 36" tall shipping and receiving directional wall sign on the southern (rear) exterior facade of the property at 80 University Avenue, Westwood, MA 02090 in accordance with PB-23-43. The property is in the University Avenue Mixed Use District (UAMUD), Industrial (I) zoning district, and Flexible Multiple Use Overlay District 1 (FMUOD1).
