Pursuant to Chapter 2 of the Acts of 2023, On March 29, 2023, Governor Maura Healey signed into law, an Act Extending pandemic-related authorizations related to public meetings, allowing remote meeting options for public bodies through March 31, 2025. The June 15, 2023 Charter Review Committee meeting was conducted via remote participation.

Chapter 8-Departments

Section 1 Finance Department 8-1-1 Created during the last Charter Review. No issues need to be addressed. A Placeholder was suggested to find out if it is covered by the Home Rule Petition. Promotion reclassification. Ask Attorney Goldberg to see who makes the appointment. Mr. Ahearn will follow up with Attorney Goldberg. 8-1-2 Ask Mr. Coleman about the name in the Charter: Finance Director/Assistant Town Administrator. 8-1-3 Looks good. 8-1-4 Works well. Appointment of the Treasurer and Tax Collector and how we want to raise that.

Why is Section 2 so short? *The Municipal Finance Department, Section 1, was not established by State Law. It was created at the last review and it was built into the Charter. Fire and Police involves state law.* We may want to add why there are not more specifics, we may want to address it to the Town.

Chapter 9-Financial Procedures Section 1 **Fiscal Year** All set. 9-2-1 Where is it, in the bylaws, only serving 2 terms in the Audit Committee. Not in the Charter or By-laws. We may want to look at term limits. Some committees have term limits. It works. 9-3-1 Should it include the school department? The budget referenced is the total budget. 9-4-6 Placeholder and ask Attorney Goldberg. Any benefit to reference to be inclusive of the School Department at any point in this section. It is a bottom line budget. 9-4-1 The School follows it, they do it by the end of January. This section works well. 9-4-5 Edit? Ask Attorney Goldberg. At least 1....meetings or meeting or hearing. 9-4-7 Provide flexibility when needed. There is a process to adopt a by-law. Consider adding to this section: Town meeting may, by town by-law(propose pursuant to Chapter 10). Reference this section to incorporate that there is a process. Ms. Powers can look back and see if there is information why this was added.
