FY24 TAX CLASSIFICATION

The Westwood Select Board will hold a remote Public Hearing on **Monday, November 13, 2023**, at 6:00 p.m., Pursuant to Chapter 2 of the Acts of 2023, on March 29, 2023, Governor Maura Healey signed into law An Act Making appropriations for the Fiscal Year 2023 to Provide for Supplementing Certain Existing Appropriations and for Certain Other Activities and Projects. This Act includes an extension, until March 31, 2025, of the remote meeting provisions.

The purpose of this meeting will be for discussion and taxpayer feedback and a vote of the Select Board to determine the allocation of Fiscal Year 2024 taxes among the classes of real and personal property as set forth in Chapter 40, Section 56 of the General Laws. Interested taxpayers may present written information on their views at the November 13, 2023, Public Hearing.
