NOTICE OF PUBLIC MEETING – QUORUM DISCUSSION**

The Westwood Select Board will hold a remote Public Meeting on Monday, January 8, 2024, at 6:00 p.m., pursuant to Chapter 22 of the Acts of 2022, where towns are allowed to reduce their Town Meeting quorum.

On December 18, 2022, at 6:00 p.m. at a regularly scheduled meeting of the Select Board, the Board will take up the issue of reducing the quorum for the 2024 Special Town Meeting, in consultation with the Moderator. The 2024 Special Town Meeting will be held on January 17, 2024.

This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real-time, via technological means. In the event that we are unable to do so, for reasons of economic hardship and despite best efforts, we will post on the Town website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting.

The meeting will be filmed live by Westwood Media Center and available for viewing on Comcast channel 6 and Verizon channel 42.
