NOTICE OF PUBLIC MEETING – QUORUM DISCUSSION**

**The Select Board in consultation with the Moderator may reduce the quorum requirement of Town Meeting as per Chapter 22 to the Acts of 2022 which was extended by Governor Healey by Chapter 2 of the Acts of 2023.**

**On January 8, 2024, at 6:00 p.m. at a regularly scheduled meeting of the Select Board, the Board will take up the issue of reducing the quorum for the 2024 Special Town Meeting, in consultation with the Moderator. The 2024 Special Town Meeting will be held on January 17, 2024.**

This meeting will be conducted via remote means. Members of the public who wish to access the meeting may do so by using the Webinar link below. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real-time, via technological means. If we are unable to do so, for reasons of economic hardship and despite best efforts, we will post on the Town website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting.

The meeting will be filmed live by Westwood Media Center and available for viewing on Comcast channel 6 and Verizon channel 42.
