Pursuant to Chapter 40A, §9, the Board of Appeals will hold a public hearing on Wednesday, February 14, 2024, at 7:00 PM. The public hearing will be a remote meeting through Zoom. On March 29, 2023 Governor Maura Healey signed into law, the Acts of 2023, which includes an extension to pandemic related authorizations related to public meetings.
